The subtenant will be liable to the sublessor for any damages occurring to the premises or damage to or loss of the contents thereof or to the building which are done by the subtenant or his guests.		
9. <b>INVENTORY FORM</b> : If any furniture or other personal property of the sublessor is to be left at the premises, the sublessor will provide the subtenant with an inventory form within three (3) days of taking possession.

The subtenant agrees to assume all of the obligations and responsibilities of the sublessor under the original lease for the duration of the sublease agreement except as otherwise set forth in this Agreement.
